John McKenzie presentation. Laguna Lake Dog Park Windbreak/Memorial Plaque Proposal. Provided overview of plan details. Followed by Commission questions. The project received Commission support. P&R Staff has reviewed, and as for all proposals, it will need to go through a full assessment by city engineering and the city attorney's office.
